These include adding public program opportunities, building one bridge over an existing tributary to protect sensitive habitat and make the trail more defined and accessible, per past discussions. Additionally, increasing school involvement for science classes and possibly history and other departments is a goal, and the UCP continuing to be an Ohio Department of Natural Resources water quality testing site is confirmed with support from Ms. Becky Donaldson of the ODNR and two RTCPD volunteers.
