PLEDGE OF ALLEGIANCE - Mr. Podojil asked for all to stand and recite the Pledge of Allegience.

CALL TO ORDER - 6:43 PM – Present were Mr. Roy Podojil, Mr. Perry Howland and Ms. Stephanie Snevel, Commissioners, and Ms. Maria Livers, Clerk.

MINUTES - Ms. Livers read the minutes of the Sept. 30th meeting into the record. Mr. Howland made a motion to accept the Minutes as submitted. Ms. Snevel seconded and the motion passed unanimously.

PURCHASE ORDERS & CHECKS - SEE ATTACHMENT

ML read each of the Purchase Orders for 2019 listed on attachment into the record. All were reviewed by all Commissioners.

A motion was made by Mr. Podojil to approve the PO list and approve and sign all Then & Now Purchase Orders, Warrants and Vouchers as listed, to bring board financial paperwork current. Ms. Snevel seconded the motion and the motion passed unanimously.

Previously tabled warrants 1006, 1007, 1008 were voided, initialed by Stephanie Snevel and witnessed by all Board members.

A motion made by Mr. Podojil to pay Geauga Co. Maple Leaf for May levy listing, per the attachment. Mr. Howland seconded, and the motion passed unanimously.

The Purchase Order list was signed and witnessed by all parties. Ms. Snevel certified the document.

OTHER – UAN presentation – Stephanie has read through the agreement and pointed out things to be aware of before entering into the contract:

- Auditor of State does not agree that using this system will necessarily save a board money.
- Need a safe location to house the hardware and software that is easily accessed.
- If we need additional assistance, we may have to pay for that they would give us a quote.
- We are responsible for replacing hardware if anything happens to it.

- We will allow reasonable access to auditor and we agree to enact updates.
- We will notify the auditor within 7 days if we relocate, for their approval.
- Upon termination, we agree to pay all transportation costs back to auditor. We agree to
 use it for intended purposes. We agree to transmit copies of our records to the Auditor
 as requested.
- User agreements and forms need to be executed prior to using the hardware and software.

 When the software and software and software.
- We agree to agree to pay quarterly payment of \$174 (\$8/month and \$50/month).
- Provider can terminate agreement if we fail to remedy breech or misuse and/or mishandle equipment.
- They are not liable to us for any defect in hardware of software.
- Upon completion of training, we receive CPU, hard drive, CD-ROM/CD-RW, keyboard, mouse, monitor + software. + printer + sunge protector and more perguent
- WE NEED TO CARRY INSURANCE TO COVER THIS EQUIPMENT.

Mr. Howland moved that we adopt the UAN process, Ms. Snevel seconded, and the motion passed unanimously.

All noted that WE NEED A LOCATION before we can sign the agreement and we NEED TO BE BONDED.
